Mayor Greuter offered to conduct the Rutgers certification class for basketball, resulting in a savings of \$200. Additional savings would be possible if the Fire Department or a coach could be trained as a CPR instructor to save the cost of paying for a class.

Basketball hires crossing guards who have already had background checks to act as hall monitors during games. The money comes out of fees that the parents pay, not taxes.

According to Mrs. Johnson, employees who are certified to conduct playground inspections have been told that they could be personally liable. The Borough Attorney will be asked if the newly adopted indemnification ordinance would provide liability protection to them.

A baseball travel team that is not affiliated with Little League or sponsored by Recreation is holding practices and meetings at the Community Center. The required insurance must be submitted.

Councilman Vicente discussed his view of hiring residents for working as part of the summer staff.

Possible small capital projects, if funding is available, would include benches for the bocci ball court, motion sensor lights at Smith Field, replacement of shingles or roof work on batting cages and dugouts, new swim lane lines (which could be postponed). Mrs. Johnson will provide a cost list to Mr. Doherty.

Discussion ensued regarding the fees or donations collected by the various sports.

PUBLIC PORTION

Mayor Greuter opened the meeting to the public. There being no comments, Mayor Greuter closed the meeting to the public.

2012 ANNUAL FINANCIAL STATEMENTS

The Chief Financial Officer did not complete all of the required items for the auditor to prepare the Annual Financial Statement and Annual Debt Statement. The auditor may assess an additional charge of up to \$7,000 to complete these items.

Upon motion by Councilman Donofrio, seconded by Councilman Willer, and unanimously carried via roll call vote, to authorize the expenditure of up to \$7,000 to the auditor to perform the necessary work prepare the Annual Financial Statement and Annual Debt Statement.

SALE OF BOROUGH PROPERTIES

Discussion ensued regarding the Borough-owned properties that will be sold at auction with the assistance of Coldwell Banker.

Upon motion by Councilman Willer, seconded by Councilman Donofrio, and unanimously carried via voice vote to sell (a) Block 31, Lots 16, 17, 18, and 19 on Van Duyne Ave. as one parcel; (b) Block 60, Lots 9 and 10 on Cedar Lane as one parcel; and (c) Block 81.06, Lot 33.02 (67 Elycroft Ave. W.) as one parcel, with the minimum prices to be determined.

Upon motion by Councilman Mulligan, seconded by Councilman Donofrio, and adopted unanimously upon voice vote, the following resolution was adopted:
