Mayor Greuter announced the appointment of Mr. Shawn Connington to the Parks and Recreation Advisory Committee for a term expiring December 31, 2014.

Upon motion by Councilman Mulligan, seconded by Councilman Donofrio, and carried unanimously upon voice vote, to concur with the Mayor's appointment of Shawn Connington, 185 Rockaway Avenue, to the Parks and Recreation Advisory Committee for a term expiring December 31, 2014.

RESOLUTION 65-13

Chief Financial Officer Marie Goble and Treasurer Yolanda Dykes were present to discuss Resolution 65-13. Ms. Goble explained that the auditor identified that the Borough's Cap appropriation amount exceeds the amount allowed by state law and that the Borough must apply for a waiver from the State Local Finance Board. Mayor Greuter read aloud Resolution 65-13.

WHEREAS, the Mayor and Council of the Borough of Rockaway in the County of Morris desires to make application to the Local Finance Board for its approval of a proposed appropriation CAP waiver pursuant to N.J.S.A. 40A:4-45.3(e); and

WHEREAS, the Mayor and Council believes that:

- (a) it is in the public interest to accomplish such purpose; and
- (b) the appropriation CAP waiver is for the health, wealth, convenience or betterment of the inhabitants of the Borough of Rockaway; and
- (c) the proposal is an efficient and feasible means of providing services for the needs of the inhabitants of the Borough of Rockaway and will not create an undue financial burden to be placed upon the Borough of Rockaway.

On motion by Councilman Willer, seconded by Councilman Donofrio, and unanimously carried by voice vote to accept the correspondence, approve the request and notify Police, Fire, and Public Works Departments, and also to request that plastic flowers not be thrown over the bridge.

Mayor Greuter read the April 9, 2013 letter from Mr. Edward Miller, representing the Crème of the Crop, thanking Mayor Greuter for his attendance at their initial meeting.

On motion by Councilman Willer, seconded by Council President Burnside, and unanimously carried by voice vote to accept the correspondence,

COUNCIL/COMMITTEE REPORTS

Councilwoman Kanigel - Finance and Licensing Committee

Library - The grant application was submitted to the Morris County Historic Preservation Trust.

Payment of Bills - Upon motion by Councilwoman Kanigel, seconded by Councilman Mulligan, and carried unanimously upon voice vote, that the bills presented to the Borough of Rockaway for payment by the Borough, as evidenced by proper vouchers, be referred to the Committee or unit contracting for same, and, when endorsed by them and approved by appropriate action of Council, that they are to be paid.

ATTORNEY'S REPORT

Insurance Requirements - The attorneys recommend that, rather than specifying limits and types, bids and quotations require insurance that must be satisfactory to attorney review and approval.

Shared Services - Mayor Greuter met with Rockaway Township Mayor regarding shared services of the Building Department.

RESOLUTION 63-13: SUPPORT S-1896/A-1503 SHARING THE BURDEN OF PROPERTY ASSESSMENT APPEAL REFUNDS

WHEREAS, when County Tax Board appeals are granted, the municipality must reimburse the property taxpayer 100% of the appealed tax levy, which includes the municipal, school, county and any special districts tax; and

WHEREAS, the municipal tax collector makes the adjustment from the appeal as a credit on the 4th quarter tax bill, resulting in the municipality's fund balance for the preceding year to be diminished, if not completely depleted; and

WHEREAS, a League of Municipalities' survey measured the extent to which residents have filed and won tax appeals in 2010; and

WHEREAS, one hundred fifty (150) municipalities, representing both large and small municipalities in all 21 counties, that participated in the survey reported property value declines of more than \$87,900,000, which resulted from 19,788 tax appeals filed in 2010; and

WHEREAS, those responding to the survey indicated that 13,760 appeals were filed in 2009, compared to 19,788 in 2010, representing an increase of 43.7%; and

WHEREAS, a municipality often experiences an increase in tax appeals because it has conducted a revaluation, however, only five of the 150 municipalities, which participated in the survey, indicated that their 2010 appeals resulted from revaluations; and

WHEREAS, as a way of comparison, 23 of the participating municipalities conducted revaluations in 2009, when fewer tax appeals were presented to the County Tax Boards; and

WHEREAS, the 2010 spike in appeals should be attributed to the economic down-turn, which lowered property values and placed increased stress on the income of homeowners, all around our Garden State; and

WHEREAS, the survey also indicated that in 2010 the various County Tax Boards have granted average property value reductions of close to \$5,000, per appeal; and

WHEREAS, fifty-six percent of those responding indicated that the successful tax appeals would have an impact on fund balances and place additional pressures on local officials during 2011; and

WHEREAS, the reductions, which were granted by County Tax Boards in 2010, likely had a multiplier in subsequent years when neighbors learned of their neighbor's tax reduction; and

WHEREAS, successful tax appeals have a three-fold negative impact on municipal budgets. First, the municipality, as the collector of taxes for the School district, county and special districts, must fund the full cost of the legal defense of the assessment. Second, since State law guarantees to the county and the school district 100% of their levies, the municipality bears the full cost of any re-imbursements resulting from the appeal (as well as the full burden for any uncollected taxes). Third, the end result will be a further decline in the property tax base used to support Municipalities, County governments and School systems; and

WHEREAS, in light of the revenue limitations that have been placed on all levels of local government by the Legislature (2% cap), such declining values will compound and add additional stress to local public officials, as they grapple with the issues confronting the tax paying public; and

WHEREAS, Senator Bucco, Assemblyman Carroll and Assemblyman Bucco have recently introduced S-1896/A-1503, which requires fire districts, school districts, and county governments to share in burden of property assessment appeal refunds;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Rockaway, County of Morris, State of New Jersey, to hereby urge the swift passage and signing of S-1896/A-1503; and

BE IT FURTHER RESOLVED, that copies of this Resolution be forwarded to New Jersey Governor Christopher Christie, to Senate President Stephen Sweeney, to Assembly Speaker Sheila Oliver, to our State Senator, to our two Representatives in the General Assembly, and to the New Jersey League of Municipalities.

ORDINANCE NO. 05-13, Public Hearing & Adoption

ORDINANCE OF THE BOROUGH OF ROCKAWAY MAYOR AND COUNCIL AMENDING CHAPTER A263, FEES, OF THE CODE OF THE BOROUGH OF ROCKAWAY

WHEREAS, New Jersey Court Rule 7:7-7, concerning municipal court discovery, was amended effective January 1, 2013; and

WHEREAS, as a result of this amendment it is necessary and appropriate at this time to revise Section A263-1P(2) of the Code of the Borough of Rockaway; and good cause having been shown.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Rockaway, County of Morris, State of New Jersey, that Chapter A263, Fees, Section A263-1, Fees established of the Code of the Borough of Rockaway be amended as set forth herein.

Section I

1. Chapter A263, Fees, § A263-1, Fees established, Section P, Service fees and copies of documents, sub-section (2) is hereby repealed in entirety and replaced with the following:

§ A263-1-P(2) Service fees and copies of documents.

"(2) Municipal Court Discovery. All requests for discovery in matters pending in the Borough of Rockaway Municipal Court shall be addressed pursuant to New Jersey Court Rule 7:7-7, and the fees for same shall be as set forth in that Rule."

Section II

- 1. This Ordinance may be renumbered for codification purposes.
- 2. All ordinances of the Borough of Rockaway which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

- 3. If any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
- 4. This Ordinance shall take effect as provided by law.
