Vermin Activity Report

There was one bed bug report at 14 Dock Street; our inspector responded talked to the landlord and an exterminator was called in to handle the situation. There were no complaints of rat activity this month.

Local Health Shared Services Update

This is information for the board. We are a regional health dept. Mark just wanted you to know what's going on in Roxbury. We do have big environmental issues in Roxbury. It's called the Fenimore garbage dump. It was closed down by the D.E.P. in the late 70's early 80's. The D.E.P. shut him down with the promise never to have it open as a garbage dump or a land fill. Through the DEP Brown fields program, an application was made by the new owner to install solar panels. Before the solar panels could be installed the proposal was to level the area. The debris from Sandy has been brought in to fill in the area. He has brought in C and D fine material which is ground up sheet rock, etc and it gives off rotten egg smell. The D.E.P. is taking action about closing it down. The operation is now closed, but odors continue.
