MAYOR & COUNCIL REGULAR MEETING SEPTEMBER 12, 2013 7:30 p.m.

The Regular Meeting of the Mayor and Council of the Borough of Rockaway, in the County of Morris, New Jersey, was held in the Community Center, 21-25 Union Street, Rockaway, N.J. with Mayor Russell Greuter presiding. Mayor Greuter called the meeting to order at 7:30 p.m.

Mayor Greuter read the following statement: In accordance with Section 5 of the Open Public Meetings Act, Chapter 231, Public Laws, 1975, be advised that notice of this meeting was made by posting on the Bulletin Board, Town Hall, and sending to the officially designated newspapers, a list of meeting dates annually, indicating that the meeting would take place at the Community Center at 7:30 p.m. on September 12, 2013. Mayor Greuter announced the location of the fire exits.

<u>Councilmembers Present</u> Thomas Donofrio Joyce Kanigel Thomas Mulligan Joseph Vicente Melissa Burnside - Council President Councilmembers Absent John Willer

Borough Attorney Edward Wacks, Esq., was also present.

Everyone present participated in the salute to the flag.

APPROVAL OF MINUTES

Upon motion by Councilman Vicente, seconded by Councilman Donofrio, and carried unanimously upon voice vote, the minutes of the August 22, 2013 Regular Meeting were accepted as submitted.

CORRESPONDENCE

Mayor Greuter read the August 30, 2013 letter from Mr. Tom Buechel, Rockaway Recycling, requesting access to conduct environmental soil and groundwater testing on Block 40, Lot 76 in order to complete due diligence on the property in advance of the pending property auction.

Mr. Wacks recommended that Ordinance 17-13, which is scheduled for public hearing and adoption this evening, be changed to give the successful bidder at the auction the opportunity to do the testing. Mr. Wacks believes it would be inappropriate to allow anyone to do any preliminary testing prior to the sale.

On motion by Councilman Mulligan, seconded by Councilwoman Kanigel, and unanimously carried via roll call vote, to carry Ordinance 17-13, with the understanding that Ordinance 17-13 will be republished due to a significant change in wording.

Mayor Greuter read a letter from Matthew Wasko dated September 10, 2013 requesting permission to sell Christmas trees from November 22 through December 24 at 100 Hibernia Avenue daily until 9:00 p.m. Mr. Wasko also volunteered to donate the tree for the Library gazebo.

Upon motion by Councilman Donofrio, seconded by Council President Burnside, and unanimously carried by voice vote to accept the correspondence, approve said sale and thank them for the donation, and to advise the Zoning Officer of same.

COUNCIL/COMMITTEE REPORTS

Councilwoman Kanigel - Finance and Licensing Committee

Library - Resolution 126-13 is for the appointment of the historical architect firm for to prepare a historic preservation plan of the Library.

Payment of Bills - Upon motion by Councilwoman Kanigel, seconded by Councilman Vicente, and carried unanimously upon voice vote, that the bills presented to the Borough of Rockaway for payment by the Borough, as evidenced by proper vouchers, be referred to the Committee or unit contracting for same, and, when endorsed by them and approved by appropriate action of Council, that they are to be paid.

Upon motion by Councilman Mulligan, seconded by Councilman Donofrio, and carried unanimously upon voice vote, to accept the Finance and License Committee report.

Councilman Donofrio - Public Works/Public Utilities Committee

No report.

Councilman Mulligan - Ordinance Committee

Recreation - The soccer parade was held last weekend. Recreation is beginning the 2014 budget process.

Ordinance 18-13 - This bond ordinance will reallocate funds from water main improvements to a pump replacement for Well No. 6A.

Upon motion by Councilman Vicente, seconded by Councilman Donofrio, and carried unanimously upon voice vote, to accept the Ordinance Committee report.

Council President Burnside - Public Safety Committee

Board of Health - Health Department has scheduled flu clinics for September 24 and October 14.

Upon motion by Councilman Vicente, seconded by Councilman Donofrio, and carried unanimously upon voice vote, to accept the Public Safety Committee report.

ATTORNEY'S REPORT

Donatoni Litigation - All paperwork has been completed. Councilman Mulligan said that the work can be done towards end of October/beginning of November.

Sale of 35 Addison Ave. - The attorneys have prepared the deeds to the property for the sale that was held.

Requested closed session for four items (current litigation in which we've been served, potential litigation regarding water meters, RVRSA possible settlement, and collection of back taxes).

Upon motion by Councilman Vicente, seconded by Council President Burnside, and carried unanimously upon voice vote, to accept the Borough Attorney's report.

MAYOR'S REPORT

Notices have been sent out regarding the poor condition of 2 Elm Street.

The Borough is participating in the County-wide McMATCH food drive competition.

Mayor Greuter read a letter from the First Presbyterian Church dated August 10, 2013 announcing the second annual neighborhood barbecue on October 5, 2013 from 11 to 3 for residents of Rockaway Borough and Rockaway Township and inviting the Borough to host a table to promote activities and services.

Mayor Greuter will attend the October 25 meeting of the Morris County Emergency Management task force.

Upon motion by Councilman Vicente, seconded by Councilman Donofrio, and carried unanimously upon voice vote, to accept the Mayor's report.

CLERK'S REPORT

Super Seniors - Eleanor Borris, Secretary of the Super Seniors of Rockaway Borough, wrote a letter dated August 30, 2013 thanking the Council for - once again - funding the club's activities for the coming year. They appreciate the fact that this \$2,500 will enable them to provide interesting programs and activities for their members.

Bingo/Raffle License Approvals - Approved a tricky tray raffle license for HSA Rockaway Borough for event to be held on December 7, 2013, at Thomas Jefferson School, 95 East Main St.

Upon motion by Councilman Vicente, seconded by Council President Burnside, and carried unanimously upon voice vote, to accept the Clerk's report.

Councilman Vicente - Personnel

Rockaway Borough Board of Education - Presented information on the school district's statistics, including student population and budget.

44 Broad Street Right-of-Way - Councilman Vicente discussed the proposal from a developer at the August 22 meeting requesting that the Governing Body consider vacating a strip of right-of-way at 44 Broad Street. The developer needed the property to build three houses rather than two houses. The Borough would receive payment for vacating the right of way. Although the vote ended in a tie on August 22, Councilman Vicente suggested that the developer be re-invited in; however, he agreed to table the vote until a full council is present.

Potential Shared Services - Construction Department

Councilman Vicente presented three options to reorganize the Construction Department services: enter into a shared services agreement with either (1) Rockaway Township or (2) the State Department of Community Affairs at no cost to the Borough; or (3) reduce the full-time Technical Assistant to the Construction Official ("TACO") position to a part-time position. A fourth option would be to remain as is. The Department, which is supposed to be self-funding, has been running at a deficit since 2009.

Mr. Len Perre, Construction Official, explained that the department is funded through user-based fees; if the department runs at a deficit, the balance is borne by the taxpayers. He recommended that, if the decision were to be Option 3, the incumbent be given the right of first refusal.

Mr. Eric Tulenko, 16 Farview Dr., asked if the State says you cannot raise fees at a certain point.

Mrs. Bonnie Hook, 23 Jackson Ave., is concerned about a reduction in services. People and contractors can't wait a week to get things done.

Mr. Sam Saporite, 34 W. Flagge St., recommended that fees be reviewed frequently instead of waiting a long period of time.

Mrs. Sylvia Banbor, the incumbent Technical Assistant to the Construction Official, noted that we are coming out of slump and hopes that the next few years will be better. A contractor from Kinnelon who is using shared services with another town told her that it is terrible to go to other town for permits.

Councilman Mulligan felt that Option 3 would be the most feasible and we would need to look within town hall to carry the workload going from full time to part time. Council President Burnside stated that if we move from full time to part time, we need to look at how things are done to gain efficiencies; can technology bring about more efficiencies or invest in tools that could decrease the burden on personnel? Councilman Donofrio said that Option 3 is the only reasonable option to explore further. Councilwoman Kanigel agreed that Option 3 is the best option; it would be easily reversible; and she would like to keep it in town.

Mr. Perre said that there are other software packages such as Spatial Data and Mitchell Humphreys that might help to increase efficiencies.

Upon motion by Councilman Vicente, seconded by Councilman Donofrio and unanimously carried via roll call vote, to pursue Option 3 for a year effective January 1, 2014, with the existing staff to remain or have right of first refusal, an evaluation of additional efficiencies will be conducted after a one year period.

Council President Burnside recommended that an evaluation of personnel in town hall be done (where efficiencies can be gained, identify the best roles, what we have now, and what would be ideal). Councilman Vicente will take the lead.

Upon motion by Council President Burnside, seconded by Councilman Mulligan, and carried unanimously upon voice vote, to accept the Personnel Committee report.

WHEREAS, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the Annual Audit, pursuant to N.J.A.C. 5:30-6.5, and;

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and;

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52-27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the Director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

WHEREAS, the Borough Council (the "Council") has determined by passage of Bond Ordinance 12-13 to issue General Obligation Bond Anticipation Notes of the Borough to fund the projects authorized by the above captioned ordinance, and to pay the cost of issuance related thereto.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Rockaway, in the County of Morris, New Jersey, as follows:

<u>Section 1</u>. Pursuant to N.J.S.A. 40A:2-8, the following amounts of General Obligation General Improvement Bond Anticipation Notes (the "General Improvement Notes") shall be issued at such dates and in such amounts as is determined by the Chief Financial Officer and/or acting Chief Financial Officer in accordance with this resolution:

a. Pursuant to Bond Ordinance No. 12-13, Notes in the principal amount of not to exceed \$285,000.00 shall be issued for the purposes stated therein.

<u>Section 2</u>. Pursuant to the provisions of Section 40A:2-26 of the Local Bond Law of New Jersey, particularly paragraph (f) thereof, and in lieu of the sale of more than one (1) issue of bonds or notes as provided for in said Local Bond Law, the issues of bonds and notes of the Borough authorized pursuant to the Bond Ordinances of the Borough hereinabove set forth shall be combined into one (1) issues of Notes to be sold concurrently in the aggregate amount of not to exceed \$285,000.00 General Obligation General Improvement Bond Anticipation Notes.

Section 3. The following matters in connection with said Notes are hereby determined:

a. All notes issued hereunder and any renewal thereof, shall mature at such times as may be determined by the Chief Financial Officer and/or acting Chief Financial Officer of the Borough, provided that any note issued pursuant hereto shall be issued for a period not to exceed one (1) year, but all such notes, including renewals, shall mature and be paid in accordance with the Local Bond Law.

b. All notes issued hereunder shall bear interest at such rate or rates as may be determined by the Chief Financial Officer and/or acting Chief Financial Officer of the Borough.

c. The notes shall be in a form as permitted by law and approved by Bond Counsel, and issued pursuant to the Local Bond Law, and any such notes or any renewal thereof, may be signed or sealed by officers of the Borough in any manner permitted by Section 40A:2-25 of said Law notwithstanding what is otherwise set forth herein.

<u>Section 4</u>. The Chief Financial Officer and/or acting Chief Financial Officer of the Borough is hereby authorized and directed to determine all matters in connection with said Notes or any renewal thereof, not determined by this or a subsequent resolution and his/her signature upon said Notes shall be conclusive as to such determinations.

<u>Section 5</u>. The Chief Financial Officer and/or acting Chief Financial Officer of the Borough is hereby authorized to sell said Notes or any renewal thereof, from time to time at public or private sale in such amounts as he/she may determine at not less than par value and to deliver the same from time to time to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from the dated date of the Notes to the date of delivery thereof and payment therefor.

Section 6. Any instrument issued pursuant to this Resolution shall be a general obligation of the Borough, and the Borough's faith and credit are hereby pledged to the punctual payment of the principal of and interest on said obligation and, unless otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget and a tax sufficient to provide for the payment thereof shall be levied and collected.

<u>Section 7</u>. RESOLUTION 121-13: AUTHORIZE DEDICATION BY RIDER TO BUDGET - POLICE DEPARTMENT DONATIONS

WHEREAS, N.J.S.A. 40A:4-39 provides for the insertion of a "Dedication by Rider" in the budget of any local unit which dedicates revenues anticipated during the fiscal year from donations to the Rockaway Borough Police Department to purchase uniforms for the Rockaway Borough Police Department, subject to written prior consent of the Director of the Division of Local Government Services, when the revenue is not subject to reasonably accurate estimate in advance; and

WHEREAS, such dedicated revenues shall be appropriated for the purpose to which said revenue is dedicated by statute or other legal requirements.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Rockaway County of Morris, State of New Jersey, that all donations to the Rockaway Borough Police Department to purchase uniforms for the Rockaway Borough Police Department, shall be placed in a specific trust fund and such trust fund shall be considered a "Dedication by Rider" to the budget of the local unit, pursuant to N.J.S.A. 40A:4-39, for the sole purpose stated above.

Mrs. Bonnie Hook, 23 Jackson Ave., reported that 70-75 vendors are signed up for Celebrate Rockaway Day. She requested that the Maple Ave. park bathrooms be opened for the day.

Mr. Eric Tulenko, 16 Farview Dr., asked for the status of the ordinance to sell Block 40, Lot 76.

Mr. Matt Leonard, 1 Stephens Pl., reported that a tree on Mountain Rd. is leaning on low voltage wires.

Kathy Haake, 74 Rockaway Ave., said that she has seen sellers require potential bidders to sign a confidentiality agreement before they bid prohibiting the release of information, including to the seller.

Mr. Saporite asked for a follow-up on the water utility discussion and asked if Mayor Greuter would include three residents on the committee. Mayor Greuter has done nothing yet.

There being no further comments, Mayor Greuter closed the meeting to the public.
