MAYOR & COUNCIL SPECIAL MEETING December 16, 2013 5:00 p.m.

A Special Meeting of the Mayor and Council of the Borough of Rockaway, in the County of Morris, New Jersey, was held in the Community Center, 21-25 Union Street, Rockaway, N.J. with Mayor Russell Greuter presiding. Mayor Greuter called the meeting to order at 5:02 p.m.

Mayor Greuter read the following statement: In accordance with Section 5 of the Open Public Meetings Act, Chapter 231, Public Laws, 1975, be advised that notice of this meeting was made by posting on the Bulletin Board, Town Hall, and sending to the officially designated newspapers, a notice indicating that a special meeting would take place at the Community Center at 5:00 p.m. on December 16, 2013. Mayor Greuter announced the location of the fire exits.

Chief Financial Officer Marie Goble and Treasurer Yolanda Dykes were present to explain the two resolutions that will be considered this evening. Ms. Goble stated that the Finance Department worked with the auditors to identify the best strategy going into 2014 to cover overruns of \$200,000.00 and \$100,000.00 in the current and water utility 2013 budgets respectively. The emergency resolutions will be sent to the Department of Local Government Services.

The current budget over-expenditures are related to police salaries/wages, legal fees, streets and roads, and health benefits. The water utility over-expenditures are for salaries/wages, operating expenses, and statutory expenses (FICA). There were unexpected costs related to the soil contamination in the Public Works yard and higher electric costs due to one well pump failure and increased use of the backup pump.

Ms. Goble explained that the \$26,264.00 difference between the \$200,000.00 emergency appropriation and \$173,736.00 representing three (3) percent of the total operation appropriations will have to be inside the CAP for the 2014 current budget.

According to Ms. Goble, \$687,000 raised in 2013 for deferred charges will be used to offset the \$300,000 that must be included in the 2014 budget for the above over-expenditures. The Finance Department is trying to get everything to balance now in preparation for 2014. The departments have held off on purchases, and transfers will be made prior to year-end.

- 1. An emergency appropriation is hereby made for Police Salaries/Wages in the amount of \$160,000.00; for Legal Fees in the amount of \$12,000.00; for Streets and Roads in the amount of \$13,000.00; and for Health Benefits in the amount of \$15,000.00.
- 2. That said emergency appropriation shall be provided for in full in the 2014 budget, within CAPS, pursuant to NJS 40A:4-53.3c(1).
- 3. That the statement required by the Local Finance Board has been filed with the Clerk and a copy transmitted to the Director of the Division of Local Government Services.
