Bidders must use, and complete fully, Proposal blanks included with the Specifications furnished by the Borough and comply with all requirements attached thereto including the following:

(1) An experience record of the Bidder; (2) A Certified Check or a Bid Bond in the amount of \$300.00 furnished by a surety company authorized to do business in the State of New Jersey; (3) A Non-Collusion Affidavit; (4) A Certificate of Surety; (5) A Qualifications Statement; (6) An Ownership Disclosure Statement pursuant to Chapter 33 P.L. 1977; (7) Business Registration Certificate.

Each Bid must be submitted and enclosed in a sealed envelope with the name and address of the Bidder. The Bid shall be submitted to the Clerk with the designation "The Provision of Emergency Medical Services and Emergency Transportation Services in the Borough of Rockaway."

Simultaneously with the submission of Bids, the corporation or partnership so bidding shall furnish a statement setting forth the names and addresses of all stockholders in the corporation or the partnership who own 10% or greater of interest therein pursuant to Ch. 33, P.L. 1977.

The Borough expressly reserves the right to reject any or all Bids, accept and enter into contract with the lowest responsible Bidder for the Project, or combined Projects, or to reject all Bids, or to waive any informalities in the Bids and accompanying documents received, should it be deemed to be in the best interests of the Borough.

The Borough also reserves the right to correct any erroneous mathematical computations in any proposals submitted, and to consider the Bid on the basis of the corrected total or totals. The written figures shall prevail over the numerical figures.

The Bidder shall comply with the requirements of P.L. 1975, Chapter 127 entitled "Law Against Discrimination". The Contractor shall be required to comply with the New Jersey Prevailing Wage Act and the Davis-Bacon Act. Bidders are required to comply with the equal opportunity provisions of New Jersey's Law Against Discrimination, N.J.S.A. 10:5-31 et seq., and the regulations promulgated thereunder, N.J.A.C. 17:27-1, et seq.

This proposal is being solicited through a fair and open process in accordance with N.J.S.A. 19:44A-20.5 et seq. The Bidder shall comply with the requirements mandated by law.
